## **Petition for New Regional Group Charter**

Persons petitioning the Board of Directors to form a new Regional Group should familiarize themselves with the By-Laws of the Early Ford V-8 Club of America, particularly Article XVIII – Regional Groups. Please also review the Regional Group Handbook, which is available on the National website or from any National Director.

Application for formation of a Regional Group shall be made to the Board of Directors of the National Club using this form, which shall be duly signed by at least five persons who are members in good standing in the National Club. The charter membership of a Regional Group shall not be less than five active members of the National Club. Upon approval of the Board of Directors of the National Club, the petitioning group may be issued a provisional charter which may be made permanent after one year, providing that the group continues to meet all requirements and obligations provided by the By-Laws of the National Club. Remember, all regional group members must be members of the Early Ford V-8 Club of America in order for National insurance to be in effect.

A chartered Regional Group shall use only the name designated in its charter. The new Regional Group name shall be the same as the area in which the headquarters are to be located after the Regional Group charter is granted. The name of the new group shall be: “The [area] Regional Group of the Early Ford V-8 Club of America.”
