The Border Affair 2022 National Tour

September 16th – 23th

Please note the deadline for registration is **August 19th, 2022**. But please also note that for much of the time on tour, we will be traveling in lightly populated areas with limited lodging availability, but also with possibly high demand. The longer that you wait to register and make your lodging reservations, the more difficult and pricy lodging availability may become. Finally, please also be aware that some seriously high elevations (9,000 to 10,000 ft. or so) will be experienced on the tour. Before you register, please assess your capability to deal with such elevations.

After receipt of the completed form, an updated (if appropriate) tour outline and the assigned registration number, together with the suggested lodging list (when it is available), as well as other pertinent information (as necessary) will be provided to the person registering.

Additionally, please note since the Covid-19 “bug” (in its various forms) is still with us, as is the Pandemic (as of this writing), things can still occur which might impact the tour in general, as well as some or all of our planned tour activities. Should such problems occur, you will be notified. Hopefully, nothing like this will happen, but these are strange times in which we live.

Please also note that you will be responsible for making your own lodging reservations, as well as reservations for any special activities (for example, the Cumbres & Toltec narrow gauge scenic railroad) that you may want to undertake. Information for such activities (at least the major ones) will be provided upon registration. But it is suggested that you might also want to research the tour route for other things/activities that may interest you. Detailed tour documents (“The Book”), including maps, driving suggestions, points of interest notations, instructions, informational materials, and other pertinent comments will be provided to registrants upon their arrival at the hotel in Trinidad on September 16th.
