

# The 2019 National Parks V-8 Tour

September 14th — 20th

## Registration Form

Please note the deadline for registration is **August 11th, 2019**. But please also note that for much of the time on tour, we will be traveling in lightly populated areas with limited lodging availability but high demand. The longer that you wait to register and make your lodging reservations, the more difficult and pricy lodging availability may become.

The registration process begins when this form is entirely filled out and forwarded, together with the total registration amount (checks made out to the Hi-Country Regional Group, with the notation of the 2019 National Parks V-8 Tour in the memo/for line) to the *Tour Chairman Louis Mraz, 11195 East Warren Avenue, Aurora, Colorado, 80014*. An updated (if appropriate) Tour outline and the assigned registration number, together with the suggested lodging list, as well as other pertinent information (as necessary) will be provided to the person registering.

Please note that you will be responsible for making your own lodging reservations, as well as reservations for any special activities (for example, the guided, 4-wheel drive Hummer Safari back country tour) that you may want to undertake. Lodging information as well as basic information for such activities (at least the major ones) will be provided upon registration. Many (if not most) of these other arrangements will require reservations prior to your arrive at the activity. Detailed Tour documents ("The Book"), including maps, driving suggestions, point of interest notations, instructions, and other pertinent comments will be provided to registrants upon their arrival at the hotel in Grand Junction on September 14th.
